Following are the rules and nomination form for the “Honor Group of the Washington Town & Country Fair Parade.” The Award will be announced in the *Missourian* no later than July 1.

#### **ELIGIBILITY**

Nominees shall be an organization of the Franklin/Warren County area that is actively involved in making our community a better place by raising funds to benefit members of the community or providing another valuable service to the community. Organization should uphold standards to be looked up to regarding volunteerism and leadership. Organization can be a for-profit or a not-for profit entity. There is no age limit for a nominee.

#### **PROCEDURE**

A. Nominations are due in the fair/chamber office located at 323 Main Street; Washington MO **by March 31**.

B. Nominations shall consist of the Official Nomination Form, including the following questions:

- Describe the nominee’s notable activities and accomplishments
- Describe how the nominee is/has been instrumental in initiating or leading efforts to benefit our community
- Describe the mission of this nominee
- How many members are in the organization? What are the ages/age range of members?
- Why should this nominee serve as Honor Group

C. The organization selected to be the Honor Group will be notified by the fair board to ensure attendance at the fair parade to be held the Sunday before the Fair.

#### **JUDGING**

Judging will be done by the fair parade committee and fair board.

The committee reserves the right to determine additional organizations for consideration.

## OFFICIAL NOMINATION FORM – HONOR GROUP

This award is designed to recognize an organization that is outstanding in the community based on volunteering, providing a valuable service to the community, and has the goals of a better community for us to reside in.
