Registration Notes for 2024

All livestock will be registered online: Registration will be accepted beginning May 1. Market animals must be tagged, properly entered and all fees paid by June 30, 2024, and exhibitor must be a member in good standing to be eligible to show.

Fair Admission: Ticket purchases will not be made through the same system as the livestock registration. Exhibitors will use the same style ticket as other fairgoers and are encouraged to get a daily reentry wristband.

Camping Reservations: NEW this year - Camping reservations taken ONLINE ONLY starting Wednesday, May 15 at 9 a.m. at www.washmofair.com/camping.

2024 LIVESTOCK RULES & REGULATIONS

Please read thoroughly.

- 1. Junior Exhibitors are those eight (8) through eighteen (18) years of age on December 31, 2023.
- 2. All Junior Exhibitors must be a member in good standing of a 4-H Club or FFA Chapter (in accordance with Franklin County rules) for the prior year (Oct. 1, 2022-Sept. 30, 2023) and be enrolled in the current year and project they are exhibiting by January 1, 2024. The previous year member in good standing requirement will be waived for first-year enrollees. Junior Exhibitors that fail to meet these requirements will be ineligible to show at the Fair.
- **3.** All Junior Exhibitors must be Show Me Quality Assurance certified at the appropriate level and provide their number at the time of fair registration. For questions on certification, contact the University of Missouri Extension Center in Union (636-583-5141).
- **4.** ALL Tag-in Pre-Registration will be online ONLY and due by Noon on Thursday prior to tagging.
 - Market Steer / Market Dairy Tagging Saturday, February 17, 2024 (make-up date for weather - February 24)
 - Market Hog / Market Lamb Tagging Saturday, April 20, 2024
- **5.** The Exhibitor MUST be present at tagging. All exhibitors, regardless of age, MUST be accompanied by a parent or legal guardian.
- **6.** Market animals must be owned by the exhibitor at the time of tagging.
- **7.** Market steers must be dehorned, have scurs removed and be castrated with a knife or verified a steer at tagging, up to and including the fair. All Steers must be shown in an appropriate cinch-type halter. Steers must be tied in their stalls with a halter and neck rope.
- **8.** Market hogs will be tagged in each ear. IF A TAG IS LOST, NOTIFY A LIVESTOCK COMMITTEE MEMBER IMMEDIATELY. FOR HOGS, THE COMMITTEE WILL RE-TAG THE ANIMAL ONCE, AS LONG AS THE SECOND TAG IS STILL PRESENT. NO ANIMAL WILL BE ACCEPTED WITHOUT AN OFFICIAL TAG.
- 9. Junior Exhibitors (Market and/or Breeding Classes) must reside in Franklin or an adjoining county. Only those exhibitors who will not sell a market animal at another fair in 2024 are eligible to exhibit a market animal. Exhibitors may tag in two market steers, two market hogs, two market lambs or two dairy cows, but may only ENTER ONE MARKET ANIMAL. Exhibitors must decide by fair registration deadline which species they will exhibit.
- **10.** All entries must be registered online with fees paid between May 1 and June 30, 2024. This registration is completed through FairEntry and is separate from the tagging pre-registration. Link to FairEntry registration will be available May 1 at www.washmofair.com/livestock.
- **FairEntry registration includes multiple steps, including registering the exhibitor, adding the entries, and paying the stall fees. Registration will be reviewed by the committee after ALL steps are completed. If approved, exhibitor will receive a confirmation e-mail.

- 11. The Fair reserves the right to refuse any application.
- **12.** No animal will be accepted at the Fair that has not been officially entered. Substitutions may only be made for breeding classes by calling the show chairman before July 31, 2024 NO EXCEPTIONS.
- 13. The charge for stall rental fees (per head) will be:Beef Breeding- \$10.00Market Dairy- \$30.00Dairy- \$10.00Market Hogs- \$30.00Sheep Breeding-\$10.00Market Lambs- \$30.00Swine Breeding- \$10.00Market Steers- \$30.00
- **14.** All animals will be inspected by a veterinarian at the gate prior to entering the fairgrounds. Health papers for all animals MUST be presented to the veterinarian at this time. PLEASE READ HEALTH REQUIREMENTS THOROUGHLY.
- **15.** Registration papers, in the sole name of the Junior Exhibitor or Partnership, MUST be furnished prior to showing in the Junior/Open Division. Crossbred animals are eligible for the Junior Show.
- **16.** All Breeding Classes are limited to two (2) entries per exhibitor. Group classes are limited to one (1) entry per exhibitor and the animals in the group classes except for get for sire in Breeding Classes, must be owned by the same exhibitor except for Get of Sire. There will be a limit of two (2) breeds per exhibitor. Crossbreeds are considered a breed.
- **17.** All exhibitors will be required to have a ticket for admission to the fair. Exhibitors that do not have a season pass or daily ticket must purchase a daily ticket at the gate.
- **18.** Exhibitor packets will be available at the Fair Livestock office from 12 PM to 2 PM on Sunday, August 4, 2024, ONE VEHICLE PASS PER FAMILY will be included in the packet. No vehicles will be allowed on the grounds without a proper pass or after 10:00 AM. Violators will be towed at the owner's expense.
- 19. Stall assignments will be made by the Livestock Committee. No displays will be allowed above the top rail in the cattle barn to allow proper ventilation. Banners and signs may be placed higher up in the barn. All fans in the cattle barn must be pointed in the same direction as assigned by the Livestock Committee.
- 20. Tack areas will be assigned by the Livestock Committee. Delivery of feed and bedding must be made before 10:00a.m. each day. No bedding will be allowed for Market Hogs. To limit overcrowding in the barn, a maximum of one stall space per animal brought to the fair will be allowed. Exhibitors in the Swine Barn will need to remove all tack, feeders and signs by 7:00a.m. on Sunday, August 11, 2024. Tack may be picked up OUTSIDE the SOUTH gate from 10:00p.m. to the close of ground on Saturday, August 10, 2024. Vehicles will not be allowed inside the gates for loading. Tack may also be moved and stored in Cattle Barn or Tack area near show arena.
- **21.** No refund of entry fees for animals not brought to the fair.

22. Market animals will be shown in weight classes as determined by the livestock officials. Scale is balanced by Livestock Committee with weights that have been weighed on a certified scale. MINIMUM and MAXIMUM weights for market animals (at time of Fair):

Hogs - 260 to 310 lbs. Lambs - 100 to 150 lbs. Steers - 1,050 to 1,500 lbs.

- 23. Market Hogs will be weighed right when they come off the trailer. Any market hog not making weight will immediately be loaded back on the trailer unless the hog will be shown in the Open Market Hog Class. Market Steers not making weight limits must leave the grounds immediately following weigh-in. Red or White ribbon market animals must be removed following the steer show. Red or White ribbon animals will NOT be allowed to hang FOR SALE signs after judging throughout the barns.
- **24.** Failure to properly care for animals and stall space will result in premium forfeiture and dismissal. This means you must care for your animals from arrival at the fair until Sunday morning at haul out. Exhibitors of livestock will be required to keep stall and aisle free of waste and debris. A Traveling Herdsman Award will be given in each market species division to the club or chapter which maintains the most attractive display throughout the Fair.
- **25.** Any person who exhibits inappropriate conduct will be immediately removed from the fairgrounds for the remainder of the fair in the sole discretion of the Livestock Committee.
- **26.** Every precaution will be taken to protect exhibitors and their exhibits. However, neither the Town & Country Fair, the Fair Board, the Washington Chamber of Commerce, the City of Washington, nor the supervisors or their assistants, will be responsible for accidents or loss associated with the exhibitor and their exhibits. The Washington Town & Country Fair is not liable for any stolen or damaged personal items before, during or after the fair.
- **27.** EXHIBITORS MAY NOT BRING COOLERS ON TO THE GROUNDS!
- 28. Junior Exhibitors must show and be able to handle their animals at all times. Only Junior Exhibitors will be allowed in the show ring during the show. Market exhibitors must be present for weigh-in, show and for the auction. EACH MARKET STEER EXHIBITOR WILL BE GIVEN A WRISTBAND THAT MUST BE WORN DURING WEIGH-IN, SHOW AND AUCTION TIME. THEY WILL ALSO GET 1 ADDITIONAL WRISTBAND THAT CAN BE GIVEN OUT TO THE EXHIBITORS MOTHER, FATHER, GUARDIAN, OR PERSON HELPING THEM WITH THEIR ANIMAL. ONLY THOSE WITH A WRISTBAND ON WILL BE ALLOWED IN THE WEIGH-IN, SHOW AND AUCTION AREA. This rule will be strictly enforced.

- **29.** All grooming at the Fair will be done by the Junior Exhibitor only in the barn or immediately adjacent to the barn. No adhesives or foreign substances will be allowed on show animals. No grooming chutes will be allowed in the alley of the Market Steer Barn during the show.
- **30.** Absolutely no drugs of any sort may be given to animals.
- **31.** Any animal deemed unmanageable by the Livestock Committee before, during or after the show will be required to leave the grounds.
- **32.** If at any time an animal deemed unsound in the sole discretion of the Livestock Committee, or veterinarian on grounds, will not be eligible to show or sell at the auction.
- **33.** All livestock being shown for judging and for sale at the Blue Ribbon Auction shall be clean and free of all decoration. No food or drink will be allowed in the Show Ring or Auction Ring.
- 34. The top BLUE RIBBON market animals in each class will be shown for GRAND CHAMPION then the second place market animal in the class the Grand Champion was picked from will be brought in for RESERVE CHAMPION. Exhibitors of market animals winning a Blue Ribbon are invited to sell at the Blue Ribbon Auction, 12:00 Noon, on Saturday, August 10, 2024. The Grand and Reserve Champions of each species must sell. Sale order will be Market Steer, Market Lamb, Market Dairy, and Market Hog. Weight upon weighin at the Fair will be used as the sale day weight for the Auction. No market animals will be allowed to be switched out at any time. The animal that is judged at the fair is the one that is sold at the fair.
- **35.** Three percent (3%) of each exhibitor's Blue Ribbon Auction check will be used to help cover the Auction Buyer Appreciation Dinner. One percent (1%) of all Blue Ribbon Auction checks will be placed into the scholarship fund. These fees will be deducted directly from the exhibitor's auction check.
- **36.** All Blue Ribbon market animals will remain on the fairgrounds until early morning Sunday, August 11, 2024. Please make sure your animal is cared for up until that time. ALL market animals must be removed by 10 a.m. on Sunday morning.
- **37.** Market & breeding animal premium voucher slips will be available at the livestock office times will be posted outside office. Any premium not picked up will be mailed following the Fair. Auction checks will be mailed following the Fair.
- **38.** The Livestock Committee will have the final decision on all questions, disputes, hardship cases, etc., that may develop. The Fair Board reserves the right to ban a violator from future fairs in the board's sole discretion.

BLUE RIBBON MILK CLASS

Animals in Blue Ribbon Auction can only be shown in Class 200. They cannot be registered for other classes.

MISSOURI ANIMAL HEALTH REQUIREMENTS

*Subject to change by the Missouri Department of Agriculture. Check with your veterinarian for the current health requirements.

General Requirements

- 1. All animals must have a Certificate of Veterinary Inspection unless specifically exempted. The Certificate of Veterinary Inspection shall state that the animal(s) are free of visible signs of contagious, infectious, or communicable disease, and describe the animal(s) by species, breed, sex and age, and include official identification where required. The Certificate of Veterinary Inspection shall reflect all data for required test and vaccinations, including dates, results, and the name of the laboratory.
- 2. The Certificate of Veterinary Inspection is valid for thirty (30) days from the date of inspection.
- 3. Animals with active lesions of ringworm with resulting loss of hair, or warts easily visible without close examination will not be permitted to exhibit and shall be subject to isolation or expulsion depending upon the nature and seriousness of the disease.
- 4. Sales scheduled in association with exhibitions must employ an accredited veterinarian to examine animals and process a Certificate of Veterinary Inspection for change of ownership when required.
- 5. The following are valid forms of official ID: 840 RFID/ EID tags, 8 or 9 character NUES tags, Scrapie tags, Brucellosis tags, or a registration tattoo if purebred and with proof of registration accompanying the animal.

Specific Requirements for SWINE

- Intrastate (swine in Missouri moving within Missouri for exhibition only)
 - a. A CVI is required.
 - b. All swine must be individually identified by official ear tag as defined by official identification, or ear notch, tattoo, or any other means of permanent identification approved by the state veterinarian, be individually listed on a CVI, and be free of clinical signs of infectious or contagious disease.
 - c. Brucellosis. No test is required.
 - d. Pseudorabies. No test is required.
- Interstate (swine from another state entering Missouri for exhibition only).
 - a. A CVI is required.
 - b. All swine must be individually identified by official ear tag as defined by official identification, or ear notch, tattoo, or any other means of permanent identification approved by the state veterinarian, be individually listed on a CVI, and be free of clinical signs of infectious or contagious disease.
 - c. An entry permit is required.
 - d. Brucellosis
 - i. Swine originating from brucellosis-free states may exhibit without a brucellosis test.
 - ii. Swine originating from a state having a brucellosis status less than free must be tested negative within sixty (60) days prior to exhibition except—
 - 1. Breeding swine from a validated brucellosis-free herd. The validated herd number and date of last validating test must be listed on the CVI.

e. Pseudorabies

- i. Swine originating from a state classified as Stage V in the National Pseudorabies (PRV) Eradication Plan may exhibit without a pseudorabies test.
- ii. All other swine must be tested negative within sixty (60) days prior to exhibition except—
 - 1. Swine from a qualified pseudorabiesfree herd. The qualified herd number and date of the last qualifying test.

Specific Requirements for CATTLE

- 1. Intrastate (cattle in Missouri moving within Missouri for exhibition only)
 - a. A CVI is required.
 - b. All animals must be individually identified by an official ear tag as defined by official identification, or registration tattoo, or any other means approved by the state veterinarian, be individually listed on a CVI, and be free of clinical signs of infectious or contagious disease.
 - c. Brucellosis. No test is required.
 - d. Tuberculosis. No test is required.
- Interstate (cattle from another state entering Missouri for exhibition only).
 - a. A CVI is required.
 - b. All animals must be individually identified by an official ear tag as defined by official identification, or registration tattoo, or any other means approved by the state veterinarian, be individually listed on a CVI, and be free of clinical signs of infectious or contagious disease.
 - c. Brucellosis
 - i. Cattle from brucellosis-free states. No brucellosis test or entry permit is required.
 - ii. Cattle from brucellosis Class A states.
 - 1. Test-eligible animals include all sexually intact animals eighteen (18) months of age and over.
 - 2. All test-eligible cattle must be tested and negative within thirty (30) days prior to entry except—
 - 3. Cattle from a certified brucellosis-free herd. The certified herd number and the date of the last test must be listed on the CVI.
 - 4. Steers. No brucellosis test required but must be individually identified and listed on a CVI.
 - 5. Rodeo bulls from a Class A state must have a negative brucellosis test within twelve (12) months prior to exhibition.

d. Tuberculosis

- i. Beef cattle—All classes of beef cattle (including exotic bovids and bison), two (2) months of age and older, entering Missouri for exhibition must meet the following requirements:
- ii. All classes of beef cattle entering Missouri for exhibition from a state having a tuberculosis-free status may enter without additional testing requirements or entry permit;

- iii. All classes of beef cattle, six (6) months of age and older, entering Missouri for exhibition from a state having a tuberculosis status less than free must meet the following requirements:
 - 1. Must obtain an entry permit;
 - 2. Must have a negative tuberculosis test within sixty (60) days of shipment, test date must be listed on the CVI; or
 - 3. Move from an accredited tuberculosis-free herd (herd test date must be lisetd on the CVI); or
 - 4. Move directly from a herd of origin that has had one (1) complete negative herd test within one (1) year (date of test must be listed on the CVI).
- iv. Dairy cattle— All classes of dairy cattle, two (2) months of age and older, entering Missouri for exhibition must meet the following requirements:
 - 1. Must obtain an entry permit;
 - 2. All sexually intact dairy cattle six (6) months and older must have a negative tuberculosis test within sixty (60) days of shipment, test date must be listed on the CVI; or
 - 3. Move from an accredited tuberculosis-free herd (herd test date must be listed on the CVI); or
 - 4. Move directly from a herd of origin that has had one (1) complete negative herd test within one (1) year (date of test must be listed on the CVI).
- v. Rodeo livestock, eighteen (18) months of age and older, must be tested negative for tuberculosis every twelve (12) months and obtain an entry permit prior to entering Missouri.
- vi. No sexually intact rodeo stock from Mexico will be permitted to enter Missouri without a negative tuberculosis test within sixty (60) days of shipment (test date must be listed on the CVI).

Specific Requirements for SHEEP

- Intrastate (Missouri origin sheep (including exotic sheep and antelope) moving for exhibition)
 - a. All sheep (including exotic sheep and antelope), regardless of age or sex, must be free of clinical signs of an infectious or contagious disease.
 - b. All sheep (including exotic sheep and antelope), regardless of age or sex, must be individually identified by an official scrapie identification as defined by official identification, or any other means of permanent identification approved by the state veterinarian identifying them to the flock of origin and be listed on a CVI.
 - c. No tests are required.
 - d. Scabies.
 - Sheep from a scabies quarantined area must be dipped or treated by an officially approved method within ten (10) days prior to exhibition.
- 2. Interstate (—Sheep (including exotic sheep and antelope) entering Missouri for exhibition only).
 - a. All sheep (including exotic sheep and antelope),

- regardless of age or sex, must be free of clinical signs of an infectious or contagious disease.
- b. All sheep (including exotic sheep and antelope), regardless of age or sex, must be individually identified by an official scrapie identification as defined by official identification or any other means of permanent identification approved by the state veterinarian identifying them to the flock of origin and be listed on a CVI.
- c. All rams six (6) months of age and older must have a negative Brucella ovis test within thirty (30) days of shipment (test date, results, and name of approved laboratory must be listed on the CVI), or
 - Move from a certified Brucella ovis free flock (must be accompanied by the certificate number and date of last test).

d. Scabies

- Sheep (including exotic sheep and antelope) from a scabies quarantined area must be dipped or treated by an officially approved method within ten (10) days prior to exhibition.
- ii. A permit number must be obtained and recorded on a CVI if the sheep (including exotic sheep and antelope) are from a scabies quarantined area.
