## **Security Deposit**

A \$100 deposit is required for each vendor. This fee is in addition to the booth rental fee. Last day to request a refund is June 1, 2024. Refunds will be issued by October 15, 2024 for vendors that meet the requirements of their contract without being assessed any fines. Vendors must request a refund, or it will be used to secure a space for the 2025 Fair.

## Reservation Deposit

A \$100 deposit is required with vendor application to reserve a booth. This \$100 is applied as a credit to your booth rental fee.

## **Additional Tickets**

Vendors can purchase additional daily or season tickets by contacting Amanda. Season passes are \$70.
